We would also like to inform you that our phase two consultation will be launching next week on the **15 June 2022**. Our phase two consultation will run for **6 weeks** closing on the **27 July 2022**, this will be our statutory phase of consultation.

Updated information on the design and layout of the sites will be available to help inform your responses to our phase two consultation questions. This will include information on the results of our environmental surveys that we have been undertaking as part of the Environmental Impact Assessment (EIA) process. As part of this, we have produced a document called the Preliminary Environmental Information Report (PEIR) for each project. We are consulting on this information as part of phase two, including our proposals and approach to environmental mitigation and enhancement measures.

If you live within the consultation zone you will receive a copy of our leaflet and feedback form next week when we launch phase two. The leaflet, feedback form and the environmental information will also be available on our project websites and to collect from the CAP sites listed above. We will also be holding **6 information events and 2 webinars** throughout phase two, the details of which are below.
